9 **I. Call to Order and Establishment of Quorum**

10
11 Max Disposti, Chair of the Board of Behavioral Sciences (Board), called the
12 meeting to order at 8:31 a.m. Roll was called, and a quorum was established.
13

14 **II. Public Comment for Items not on the Agenda**

15
16 Perla Hollow: Due to the recent social justice movement, requesting to change
17 the structure of mandatory continuing education (CE) credits and is requesting to
18 mandate 4 CE units, required each renewal cycle, related to mulit-cultural,
19 LGBTQ+ and gender competence.
20

21 Herbert Weiner: The Governor issued an “appeal” for Licensed Clinical Social
22 Workers (LCSW) in light of the pandemic. Due to the 6-year time frame, Weiner
23 cannot provide services during the pandemic. He appealed the 6-year time
24 frame in 2011 and lost the appeal. He also lost his hours required for licensure.
25 This issue needs to be addressed.
26

27 Nhi T. Pham: Kaiser is one of the largest employers of medical social workers in
28 California. Kaiser has both for-profit and non-profit entities. Medical social
29 workers have the same job duties in both of its for-profit and non-profit settings.
30 As a result, each site has a different requirement for supervision. The non-profit
31 cohort can hire someone to provide clinical supervision; Kaiser’s for-profit cannot.
32 Instead, they are restricted to a supervisor who is employed full time in the same
33 building as the supervisee. The regulations overlook the complex financial and
34 organizational of major healthcare institutions. Requests that the Board extend
35 the bill’s timeline with a follow-up discussion with medical social workers and
36 address these disparities.
37

38 Rebecca Gonzales, NASW-CA: Problems scheduling exams due to the
39 pandemic.
40

41 Tonya Salas: Difficulties in finding a test center that is open and located at a
42 reasonable distance.
43

44 Josey Baker: Echoing Nhi Pham’s comment. Asked the Board to review their
45 petition.
46

1 Rebecca, ASW: Echoing Rebecca Gonzales regarding difficulty in scheduling
2 exams.

3
4 **III. Suggestions for Future Agenda Items**

5
6 Brew: 1. Discussion regarding Kaiser medical social workers to ensure equity in
7 their ability to provide services. 2. Consider adding mandatory CE units related
8 to diversity issues, specifically race, ethnicity, LGBTQ+, gender and gender
9 identity, religion, disability and social class.

10
11 Ranasinghe: Add poverty and immigration to Brew's suggestion.

12
13 Wong: Discussion regarding telehealth and competency required for licensees
14 and associates.

15
16 Disposti: Presentation of overview for exams and development.

17
18 Sovec: Explore data collection on the social economic and cultural diversity of
19 people that are being cited by the Board, those who are requesting a petition
20 hearing, licensees being placed on probation.
