Subject: Licensing Report

Licenses Population

A total of 4,088 new registration/licenses were issued in the third quarter of fiscal year (FY) 2022/2023. As of April 1, 2023, the Board has 135,648 licensees which is an approximate 1.5% gain since the second quarter of FY 2022/2023. This figure includes all licenses that have been issued and that are current and/or eligible to renew.
