### SOCIAL MEDIA ENGAGEMENT

The Board continues to use social media to communicate with licensees, applicants, and consumers. The Board has noticed some decreases in Facebook and Instagram reaches. The decreases are likely a result of the cyclical nature of the volume of workload. As a result of the graduation season, new applicants have submitted their applications and are now monitoring social media for processing time updates.

The Board's Facebook page reach was down 27.6% and the Instagram page reach was down 10.5% since the last report. However, the Board's Facebook and Instagram Page and Profile visits have increased dramatically, 101.4% and 69.6% respectively. Both the Board's Facebook and Instagram pages have steadily increased followers.

## **Twitter (X) Reporting Changes**

Since Twitter has changed to X, the analytics provided by the social media platform are limited. Board staff continue to monitor and evaluate its use of Twitter or X account and consider how to better use the platform or whether to continue using this platform.
