**Subject: Overview of Board's Current Outreach Efforts.** 

The Board employs several methods to provide outreach and education to its licensees and the public.

#### **Website**

The BBS website (<a href="www.bbs.ca.gov">www.bbs.ca.gov</a>) serves as a main resource for licensees and consumers. It includes information on licensure requirements, application process, continuing education, complaint processes, and updates on regulations and policies. This information is organized under seven main tabs: About us, Updates/FAQs, Applicant, Consumers, Exams, Licensees and Resources. Board staff is currently reviewing the content and organization of the Board's website with the goal of enhancing its accessibility and ensuring that information is easier to find and navigate. #### Social Media

In 2020, the Board expanded its use of social media to enhance outreach efforts, resulting in a significant increase in its online presence. Since then, the Board's social media reach has more than doubled, with Facebook followers growing from around 5,000 in 2020 to 32,000 today. Social media posts cover a range of topics, including processing times, Board meeting alerts, and recognition of mental health initiatives. A key factor in the success of the Board's social media strategy has been its active engagement with users, responding to comments and hosting live events. The Board is currently working on reinstating these live events to address common questions and provide further clarity on the licensure process.

#### **Outreach Events**

Upon the request from institutions, the Board hosts webinars and informational sessions, offering students insights into the licensure process, including detailed explanations of requirements and common challenges. Additionally, the Board actively engages in stakeholder meetings with various California professional organizations and attends their annual conferences. Looking ahead, the Board plans to expand its

outreach by increasing the promotion of these activities and strengthening communication with institutions and educators. Recently, the Board designated an Outreach Coordinator to manage its outreach efforts and has created a dedicated email inbox for requesting outreach events, making it easier for individuals and organizations to connect with the Board. #### **Board Newsletter**

The Board publishes at least three newsletter every year. The newsletters contain information on regulatory changes, legislative updates, licensing tips, best practices, and disciplinary actions. Newsletters are distributed to licensees via email and posted online. (Attachment C: Newsletter Content FY 2024/2024, Attachment D: 2024 BBS Fall Newsletter)

#### **Subscriber List**

The Board maintains a subscriber list that enables individuals to receive important updates and information directly from the Board. Subscribers can choose to receive notifications about various Board activities, including changes in regulations, licensing updates, public meetings, and other relevant news. Currently, there are three distinct lists available for subscription: general information, enforcement actions, and school/agency outreach. Staff is currently exploring additional ways to enhance the use of the subscriber list to further engage and inform stakeholders.

#### **Publications**

The Board offers a variety of publications focused on licensing, consumer safety, and education, all accessible through its website. Key consumer publications include "Therapy Never Includes Sexual Behavior" and "Self-Empowerment: How to Choose a Mental Health Professional," available in 13 languages. For applicants, the Board provides handbooks that outline the licensure process and answer frequently asked questions. The Board has also developed telehealth best practice documents for therapy providers, tele-supervision providers, and consumers receiving telehealth therapy. #### **BOARD CHAIR MESSAGE**

I hope that all of you had a relaxing and enjoyable summer and are enjoying the cooler fall weather. I am excited to work with my students and clients as they venture into a new year of learning. I am also excited about the work we have done through the Board of Behavioral Sciences (BBS) to support consumers and stakeholders alike.

I am pleased to announce that during our May meeting, the Board unanimously voted to continue with the current leadership. I will continue to serve as Chair, with Wendy Strack as Co-Chair. I would like to express my sincere gratitude to Governor Gavin Newsom for my reappointment and extend my congratulations to Nick Boyd on his reappointment as well.

On a celebratory note, I would like to acknowledge Yvette "Yvie" Casares Willis for her dedicated service as a member of the Board from February 2021 to March 2024. Her contributions have been invaluable, and we are grateful for her commitment to the Board.

We are also excited to announce the appointment of new public Board member Lorez Bailey. Welcome Lorez and congratulations!

I want to remind everyone of the ongoing discussions regarding the acceptance of the Association of Marital and Family Therapy Regulatory Board's (AMFTRB) Marital and Family Therapy National Examination for licensure in California. During the May 2024 Board meeting, the Board directed staff to draft the necessary legislative or regulatory language with legal counsel, address content and measurement concerns with AMFTRB, and ensure accessibility for exam candidates during the transition. This discussion will continue during upcoming Board meetings.

In legislative news, I am thrilled to report that Senate Bill 1024, introduced by Senator Rosilicie Ochoa Bogh, has been signed into law by Governor Newsom. This bill marks an advancement in modernizing mental health services and supervision standards. It updates the requirement for a licensee or registrant to physically display a license or registration to account for services delivered via telehealth. It also clarifies who counts as a "supervisee" for purposes of group supervision and specifies who is

included in the limit of six supervisees receiving individual or triadic supervision per supervisor in non-exempt settings. BBS recognizes the importance of this legislation in furthering consumer protection and extends its deepest thanks to Senator Ochoa Bogh, her office, and our stakeholders for their collective efforts in bringing this bill to fruition. For more information about this bill, see page 2.

Finally, to achieve our strategic goal of engaging stakeholders through continuous communication about the practice and regulation of the professions and mental health care, we are forming the Outreach and Education Committee. This committee will be chaired by Dr. Annette Walker and is tasked with enhancing consumer education, extending the Board's reach to more diverse populations, increasing engagement with schools, and boosting participation in Board meetings.

#### IMPORTANCE OF MAINTAINING A VALID EMAIL ADDRESS WITH THE BOARD

The Board strongly encourages all licensees, associates, and individuals in the exam process to ensure that their current email address is on file with the Board. The email address you provide will not be disclosed to the public.

This is important for everyone, but especially registrants working on passing an exam. This is because candidates are notified of approval to test via email. Without an email address on file, they will not receive notification of how to register for and schedule the exam.

#### **DID YOU KNOW?**

The email address you provide when creating a BreEZe account is not automatically uploaded into your record. Even if you have

created a BreEZe account, your email address may not be accessible to Board staff.

#### HOW TO ADD OR UPDATE YOUR EMAIL ADDRESS

You can easily add or update your email by accessing the "Change of Address Application" located within the drop-down menu under "Manage Your License" on BreEZe. See **BreEZe Helpful Hints** for further details.

#### **EMAIL ADDRESS REQUIRED EFFECTIVE JULY 1, 2022**

All licensees, registrants, and applicants who have an email address are legally required to provide it to the Board. The Board must be notified of any changes to your email address within 30 calendar days of the change.

# SB 1024 PASSES: UPDATES SUPERVISION REQUIREMENTS AND CLARIFIES DISPLAY OF LICENSE FOR TELEHEALTH

A new law, **SB 1024**, sponsored by the Board of Behavioral Sciences (BBS), becomes effective on January 1, 2025, with the goal of furthering consumer protection. It clarifies two key points pertaining to supervision, and modernizes the display of license requirement to account for telehealth. FAQs regarding these new laws are available on the home page of the Board's **website**.

## Clarification of who Counts Toward the Limit of Eight in Group Supervision

The bill clarifies who counts toward the limit of eight supervisees in group supervision. Effective January 1, 2025, the law specifies that the group may contain no more than eight persons "receiving supervision for providing clinical mental health services in all settings."

# **Specifying Who Counts Toward the Limit of Six Individual** or **Triadic Supervisees in Nonexempt Settings**

This bill also specifies who is included in the limit of six supervisees receiving individual or triadic supervision per supervisor in nonexempt settings. Currently, only registered associates count toward that limit. Effective January 1, 2025, the law specifies that persons who are not fully licensed at the highest level for independent clinical practice and who are receiving supervision for providing clinical mental health services count toward the six supervisee limit per supervisor in nonexempt settings. This includes associates, trainees and other individuals not licensed at the highest level.

In addition, the law now also clarifies that the limit of six

supervisees per supervisor applies across all nonexempt settings in which the supervisor is working, if they work for multiple employers.

(Note: A **nonexempt** setting is any setting that does not qualify as an exempt setting. It includes private practices, professional corporations, and any other types of entities that don't meet the definition of an exempt setting. An exempt setting is defined in law as a governmental entity, a school, a college, a university, or an institution that is both nonprofit and charitable.)

#### **Display of License**

This bill implements a change to the legal requirement that licenses and registrants display their license or registration in a conspicuous location at their primary place of practice. To account for the increasing use of telehealth, and the difficulty of physically displaying a license or registration when providing telehealth services, effective January 1, 2025, licensees and registrants are only required to display their license or registration in a conspicuous place in their primary place of practice when rendering professional clinical services in person. The license or registration does not need to physically be displayed when services are provided via telehealth.

To ensure that all clients maintain access to essential information, the law requires additional information to be included in the required "Notice to Clients" that a Board licensee or registrant must provide each of their clients upon initiating psychotherapy services. For all new clients for whom services are initiated on or after July 1, 2025, the "Notice to Clients" must contain the following information in addition to the information currently required to be in the notice:

- The licensee or registrant's full name as filed with the Board.
- Their license or registration number.
  - The type of license or registration (for example, licensed marriage and family therapist, associate clinical social worker, etc.).
  - The expiration date of the license or registration number.

The "Notice to Clients" containing the new information must only be provided to clients whom you begin serving on or after July 1, 2025. There is no requirement to provide an updated notice to your current clients.

# BBS CONSIDERS MOVING TO AMFTRB NATIONAL EXAMINATION

The Board discussed moving to the Association of Marital and Family Therapy Regulatory Boards (AMFTRB) exam for use as the California MFT clinical exam at its May 17, 2024 Board meeting. The Board voted to begin the process of pursuing legislation and/or regulations regarding the national exam, assuming some conditions can be met including: addressing examination content and measurement scope concerns, addressing accessibility for testing candidates to ensure they are not adversely affected, and ensuring that the transferring of eligibilities and exam information is automated. Board staff is in the process of working with AMFTRB to address the Board's concerns, as well as examining legislative and regulatory changes that will be needed. Staff will provide status reports at future Board meetings.

# GOVERNOR PROCLAIMS ADVERSE CHILDHOOD EXPERIENCES AWARENESS DAY

Governor Gavin Newsom issued a **proclamation** declaring May 11, 2024, as Adverse Childhood Experiences (ACEs) Awareness Day.

As part of the Children and Youth Behavioral Health Initiative, the California Surgeon General launched an ACEs and Toxic Stress Healing-Centered Awareness Campaign to improve our understanding of ACEs and toxic stress and connect youth, young adults, and those who support them with strategies that promote healing.

#### **PROCLAMATION**

Ensuring that the youngest Californians have a healthy start in life is one of the best investments we can make in our state's future. Today, we shine a light on the importance of preventing and addressing Adverse Childhood Experiences and their wide-ranging impacts on individuals, communities, and our state as a whole.

Adverse Childhood Experiences are highly stressful and potentially traumatic experiences that, without proper care, can lead to toxic stress—a prolonged activation of the stress response systems that can disrupt the development of brain architecture and other organ systems. Toxic stress is a root cause of many chronic health and societal challenges, from heart disease to homelessness. ACEs affect millions of Californians. A recent survey conducted by RAND found that 60% of surveyed individuals have experienced at least one ACE, and 23% of youth and 30% of parents and caregivers have experienced four or more ACEs.

California has taken significant action to prevent and address the negative health impacts of ACEs. The ACEs Aware Initiative, led by the Department of Health Care Services in partnership with the California Surgeon General, provided the funding to move the needle on ACE screening and treatment of toxic stress. To date, more than 35,300 individuals have been trained to screen for ACEs and more than 2.3 million screenings of more than 1.5 million Medi-Cal members have taken place.

As part of the Children and Youth Behavioral Health Initiative, the California Surgeon General is this month launching an ACEs and Toxic Stress Healing-Centered Awareness Campaign to improve our understanding of ACEs and toxic stress and connect youth, young adults and those who support them with strategies that promote healing.

On Adverse Childhood Experiences Awareness Day and throughout Mental Health Awareness Month, I urge all Californians to learn about evidence-based prevention and healing strategies to help the next generation of Californians lead happy and healthy lives.

NOW THEREFORE I, GAVIN NEWSOM, Governor of the State of California, do hereby proclaim May 11, 2024, as "Adverse Childhood Experiences Awareness Day."

#### AVOID LOSING YOUR HARD-EARNED EXPERIENCE HOURS

This two-part article is designed to help applicants and registrants avoid the pitfalls that can cause them to lose their hard-earned supervised experience hours. Don't let this happen to you! Learn all about how you can avoid this.

#### PART 1: TIPS FOR ASSOCIATE APPLICANTS, NEW ASSOCIATES AND MARRIAGE AND FAMILY THERAPIST (MFT) TRAINEES

 Read the FAQs for associates and refer to it often (available at www.bbs.ca.gov>Applicant>(License Type)>Forms/Pubs>Pubs).

FAQs for MFT Trainees and Associates FAQs for ASWs FAQs for APCCs

 Know the 90-Day Rule. The law allows applicants for Associate registration to count experience gained between the degree award date and the issue date of the registration if the Associate application is received within 90 days of the qualifying degree award date. However, applicants who graduated on or after January 1, 2020, may only count post-degree hours of experience under the 90-day rule if their workplace required them to complete Live Scan fingerprinting prior to gaining the post-degree hours. If the applicant's employer does not require fingerprinting, or if the applicant cannot obtain a copy of the completed "Request for Live Scan Service" form, post-degree experience gained prior to the issue date of the Associate registration will not count. See the 90-day Rule FAQ for more information.

 Be aware of the six-year age limit on supervised experience. Ensure that you complete all required experience within the six years immediately preceding submission of your Application for Licensure. Otherwise, your application will be deficient. You will have one year to clear any deficiencies. Once cleared, you will be eligible to take the clinical exam.

- Renew your Associate registration in a timely manner. Your registration must be current for experience hours to count. To avoid lapses in your registration, make sure you schedule and take the Law and Ethics Exam for your registration type well in advance of your registration's expiration date, a requirement for renewal. Once you pass the exam, you have satisfied the requirement and will not need to continue taking it each year.
- Apply for a subsequent registration early. If your registration is nearing its six-year maximum, you can apply for a subsequent registration up to 90 days prior to your registration's cancellation date. Applying early allows time for the Board to process your application and issue your new registration. Also, be aware that applicants must have passed the Law and Ethics Exam to obtain a subsequent registration.
- Ensure that your supervisor meets the licensure requirements. A supervisor must have held an acceptable license for at least two years prior to supervising and maintains a current and active license while supervising. Supervisor qualifications can be found in the Supervision Agreement. You can check your supervisor's license status at www.breeze.ca.gov.
- Ensure that you are employed as either a W-2 employee or a volunteer, and not as an independent contractor while gaining your experience hours.
- Ensure that you and your supervisor complete all required supervision forms at the start of supervision.
   Keep these completed forms in a safe place.
- Ensure your supervisor signs your experience log on a weekly basis.
- Have your supervisor sign your experience verification form upon conclusion of supervision. Don't wait until a later date, as unforeseen issues can arise with obtaining signatures later. Keep your signed form in a safe place.

# PART 2: TIPS FOR INDIVIDUALS WHO HAVE SUBMITTED AN APPLICATION FOR LICENSURE

 Respond to Deficiency Notices Within One Year. If you receive a deficiency notice, you must submit the information required to clear any deficiencies within one year from the notice date. If not, the law specifies that an applicant's file shall be closed. If this occurs, the applicant needs to reapply, and their experience hours would only count six years back from the new application date.

- Take the Clinical Exam at Least Once a Year.
   An applicant must:
  - Sit for the clinical exam within one year of being notified of eligibility to take the exam.
  - Retake the clinical exam within one year of being notified of failing the clinical exam.

If an applicant fails to take the clinical exam within their one-year window, their file will be closed. The applicant would need to reapply, and their experience hours would only count six years back from the new application date.

To help ensure you meet your one-year timeframe for taking the clinical exam, make sure you do the following:

- Don't wait until your one-year timeframe is near its end to schedule your exam. Leave yourself a cushion in case you are unable to take the exam and need to reschedule due to an unforeseen event (being sick, vehicle breaking down, etc.).
- If you require testing accommodations, apply for them well in advance of your desired test date.
- Know the process and timeframes for scheduling the clinical exam, including the testing vendor's change/cancellation policy.
- Know the requirements for participating in the exam as specified in the Candidate Handbook, such as identification requirements and security requirements.

Knowing this information will help you avoid problems with obtaining a test date prior to the close of your one-year window, or being turned away at the test site due to noncompliance with the testing vendor's requirements.

• Submit your Request for Initial License Issuance in a timely manner. If you fail to submit this request (including the initial license fee) within one year after notification by the Board of successful completion of examination requirements, your file will be closed. The applicant would have to reapply, and their experience hours would only count six years back from the new application date.

<sup>\*</sup> With the exception of 500 practicum counseling and supervision hours for LMFT applicants, which can be any age.

#### **NEW STATE OF CALIFORNIA WEBSITE: MENTALHEALTH.CA.GOV**

In May 2024, Governor Gavin Newsom announced a new state website offering life-saving resources, links to mental health support hotlines, and resources for all Californians—from youth and young adults, to older Californians, parents and families, veterans, and everyone in between: **Mentalhealth.ca.gov.** It also includes key information on California's behavioral health system transformation—accelerated by Proposition 1—and links to program and policy specifics.

On August 30, 2024, Governor Newsom unveiled a new slate of accountability tools on mentalhealth.ca.gov to track progress on the implementation of Proposition 1 and other critical mental health and substance use initiatives to expand access to care and supportive housing. The website now features thermometers that will be continuously updated to show exactly how many new treatment slots are being built for outpatient visits, residential beds for inpatient treatment, permanent supportive housing units, and housing units for veterans.

The website also features new maps that show which counties have started **Community Assistance**, **Recovery and Empowerment (CARE) Court**, an innovative program aimed at helping Californians with psychosis and schizophrenia. There are also separate maps to track which counties are implementing **reformed conservatorship laws** to support those unable to care for themselves.

#### HOLDING COUNTIES ACCOUNTABLE

The website features a new guide for Californians and local leaders that explains who to contact and what to ask to learn more about progress being made in your county. The guide can be found **here**.

#### **BIGGER PICTURE**

California is transforming the behavioral health delivery system to improve access, accountability, transparency, and capacity of behavioral health care settings for Californians. This includes Proposition 1, which has two parts: a \$6.4 billion Behavioral Health Bond for treatment settings and housing with services, and historic reform of the Behavioral Health Services Act (BHSA) to focus on people with the most serious illnesses, provide care to people with substance disorders, and support their housing needs.

#### **RECENT UPDATES**

In July, Governor Newsom announced the release of up to \$3.3 billion in competitive grant funding from Proposition 1 to expand the number of treatment facilities and beds for individuals experiencing mental health conditions and substance use disorders—with a particular focus on people who are most seriously ill, vulnerable, or homeless. The Proposition 1 Bond Behavioral Health Continuum Infrastructure Program (BHCIP) round 1: Launch Ready Request for Application (RFA) is now live and applications are due to the California Department of Health Care Services (DHCS) on December 13, 2024. A second round of funding from Proposition 1 bonds (up to \$1.1 billion) will support even more behavioral health facilities in 2025.

#### WHAT'S NEXT FOR PROP. 1?

Up to \$2 billion in Proposition 1 funds to build permanent housing with onsite services for veterans and others who are homeless or at risk of homelessness and have mental health or substance use disorder challenges will be issued by the Department of Housing and Community Development (HCD) in collaboration with the California Department of Veterans Affairs. HCD is expected to provide guidance for potential grantees by late 2024.

Together, these rounds of bond funding will invest the voter-approved Proposition 1 \$6.4 billion in local communities by 2026 to build California's behavioral health care system and improve health and wellness for all.

Reforming the Mental Health Services Act into the Behavioral Health Services Act is the other half of Proposition 1. In early 2025, DHCS will issue guidance to counties about creating a single county plan for the use of all local behavioral health dollars. Counties will report on all local behavioral health needs, inequities, services, and outcomes. These new, united county plans go into effect July 1, 2026. # RECOVERY TREK: THE BOARD'S NEW DRUG AND ALCOHOL TESTING VENDOR

As part of the disciplinary process, a licensee or registrant may be required to test periodically for the presence of drugs or alcohol as a term and condition of their probation. The Board transitioned to a new drug and alcohol testing vendor on September 3, 2024, following the expiration of our contract with Vault Health. As part of the process, DCA solicited bids to secure a testing service, with Recovery Trek emerging as the selected provider. Board staff have worked diligently to ensure a seamless transition for probationers, and 100% have successfully enrolled. Under the new contract, probationers will be able to perform remote blood tests when ordered. The Board is optimistic that this new partnership will continue to enhance public safety.
